Are there services covered before you meet your deductible?	Yes. Services from Indian Health Care <u>Providers</u> , In-Network Preventive Health <u>Care services</u> , services with a <u>copayment</u> , and certain <u>prescription drugs</u> are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes.

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
