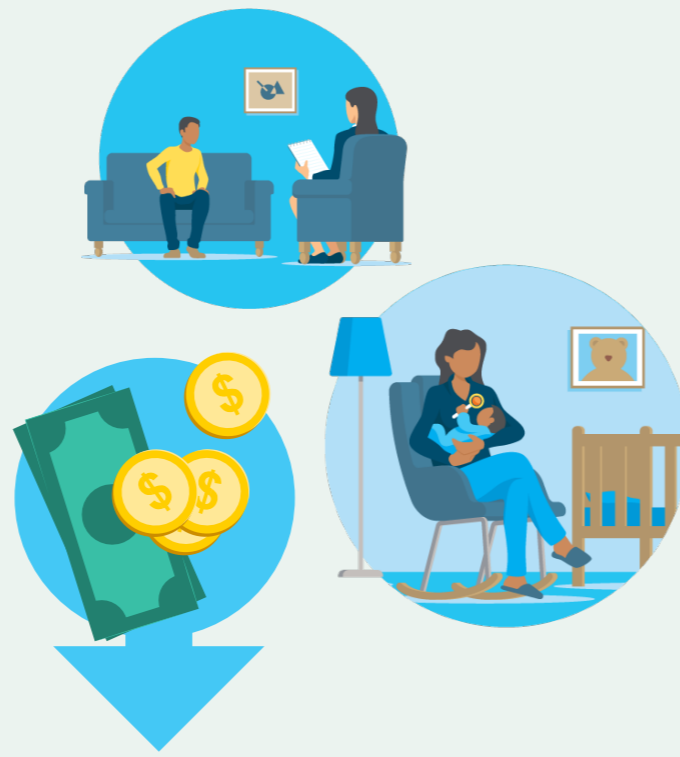

#### TRS-ActiveCare HD

- Individual and family maximum out of pocket increased to meet IRS guidelines.
- Individual and family deductibles increased to comply with IRS HSA requirements.

#### TRS-ActiveCare Primary

- Individual and family maximum out of pocket increased.

#### These changes apply to all plans:

- **Starting Sept. 1, 2024, prior authorization will be referred to as Recommended Clinical Review.** RCR is an optional review of certain services, procedures and treatments to determine if they are medically necessary.
- **The Blue Points<sup>SM</sup> rewards online shopping mall will retire at the end of 2024.** Physical merchandise will be transitioned to e-gift cards.

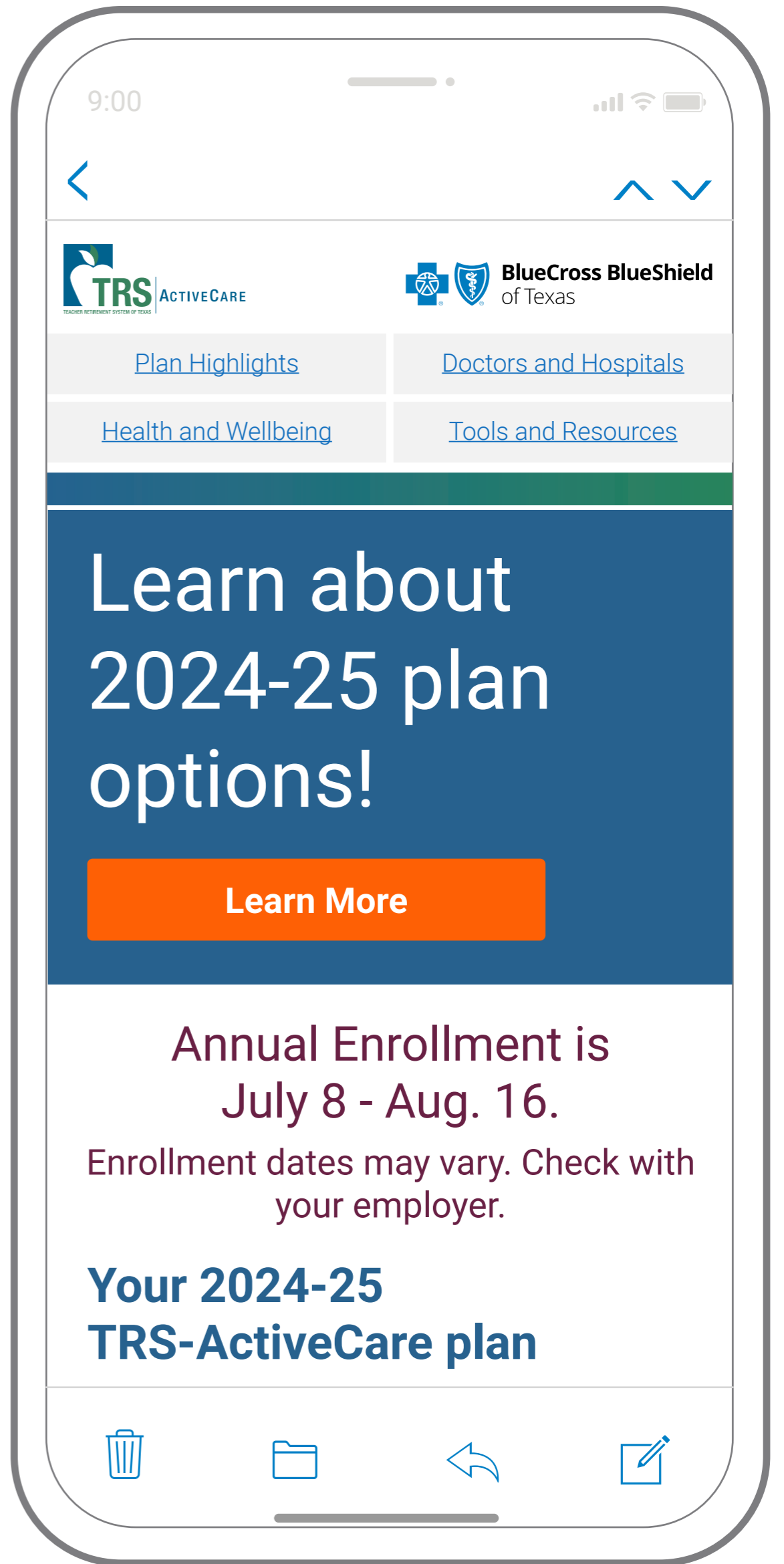

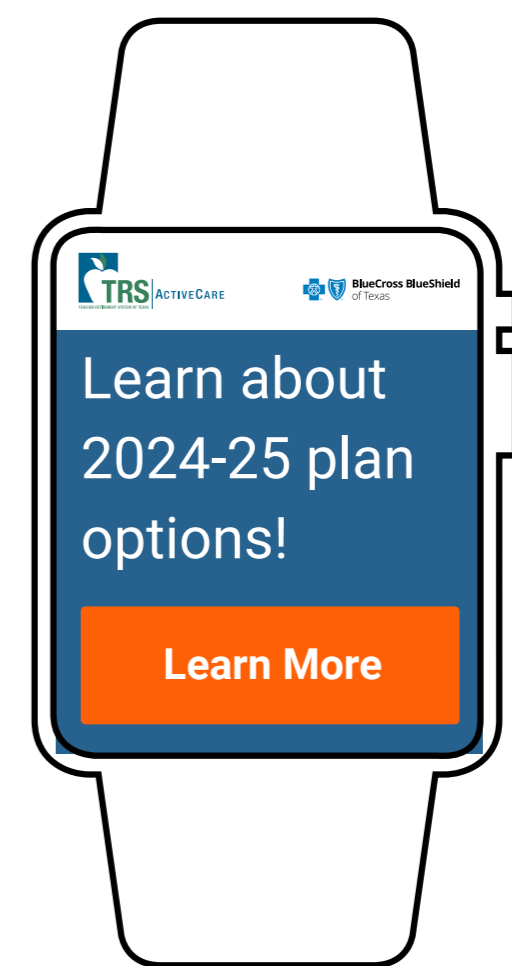
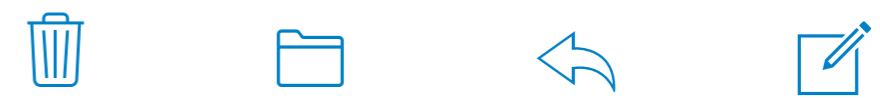
